Courtney Bricker-Thanked the Mt. Sterling church of the Nazarene for the clean up weekend, it was huge success! Courtney has a biologist inspecting the roads in the Maronda subdivision to see why the cracks are there and the huge separation of the road. Courtney attending the National Day of Prayer on 05/03/18 and reported that there was a great turn out of invited people and community churches. Courtney and Mayor Martin met with ODOT on the project (paving) that will be completed on 62 and 207 in 2019. Courtney reported that an anonymous donator donated all American flags that line the downtown and major roads.
