Village Administrator:

- New Water Supply Plant:
 - Ground breaking went very well.
 - Work has started on excavation.
- Current Water Supply Plant Repairs:
 - The aerator tower is back in service and operating well.
 - Once the first clarifier is back in service, we will empty and clean the second clarifier in preparation for repairs.
 - Once we have emptied the second clarifier, we will empty and clean the re-carbonation tank to ensure we do not have any residual sludge in it.
 - Hope to be finished by mid-May.
- Hydrant Flushing:
 - We had to emergency flush the hydrants in the Wingate Subdivision. Experienced some discoloration and pressure drop during the flush. Residents were advised to run their water for a while to help clear their lines.
- Personnel:
 - The HR package is about complete and most components have been briefed to the Finance Committee. I will submit the entire final package in the next week or so with suggestions for consideration for adoption.

We calculated leave balances for all employees to try to get a baseline of balances for each. Those balances will begin to appear on payroll stubs when we activate those functions with the payroll service.

Street sign/Stop signs/Speed bumps:

We replaced several more faded stop signs in alleys.

We posted several intersection signs at locations that had none.

Received art work and quote from Kleem.

• Cliffview Water Run-off:

We spoke to Morrison Excavating to seek a quote on the work to drain water from the area. We received a quote for the survey for the project that raised an eye brow. We are looking at other options but remain committed to applying a solution.

• Street/Alley Maintenance:

We are continuing our alley and street maintenance.

Storm Drain/Water Supply/Waste Pipes:

The storm basin at Yankeetown St. and Woods Ave. seemed to work well during the last couple of rains.
