Village of Mount Sterling Council Council Meeting Minutes Monday July 28, 2014

The meeting was called to order at 7:03 p.m. by Mayor Charles Neff.

The Mayor commented on an e-mail he received from Rose Kennedy in regards to a flag in Wisconsin.
